Findings of Fact

The applicant requested a Conditional Use approval for a Medical Marijuana Retail Store on January 8, 2020. The Code Enforcement Officer accepted the application as complete and scheduled it for a Public Hearing with the Town of Lisbon Planning Board on January 23, 2020. On February 13, 2020, the Planning Board held a Site Visit followed by a Public Hearing. On February 13, 2020, the Planning Board approved the Conditional Use Application with conditions.

Conclusion of Law

- 2. Applicant becomes the legal owner of the property prior to obtaining licensing from The Lisbon Town Council.

Mr. Lunt asked if he would be closing his existing business in the Industrial Park. Mr. Smith stated that he is not closing it, but moving the retail part of it to the Canal Street location, keeping the Industrial Park location for growing.
