- 6. UNFINISHED BUSINESS Findings of Fact Tier 2 Site Plan Review Springworks Farm Expansion

## **Findings of Fact**

The applicant proposed an expansion to the existing commercial greenhouse business at 347 Lisbon Road, Lisbon, Maine 04250

The Planning Board first considered the application on July 9, 2020. On July 9, 2020 the Board accepted the application as complete. On July 23, 2020 the Board held a Site Visit to review the project. On July 23, 2020 the Board conducted a public hearing. On July 23, 2020 the Board approved the project with conditions.

Conclusion of Law

Therefore, the Planning Board hereby approves the application for Springworks Farm expansion with the following conditions:

- 2) Landscape plan showing paved aprons at all entrance and exit ways.

## 7. OTHER BUSINESS - CDBG Funds - Lisbon Development Committee - Brett Richardson, ECD

Mr. Kuhl recused himself from the discussion and voting since he works for the Agency that funds this project.

Mr Douglas explained that the town is seeking CDBG funds for two projects. The first one being a business façade program funded by CDBG Community Enterprise program for someone who is looking to improve their façade along Route 196 and the second one is an affordable housing development at Farwell Mill apartments, funded by the CDBG Housing Program. He explained after successful completion of the project development phase for both projects, the Town will be awarded \$100,000 for the Business Façade Program and 1,000,000 for the Housing Project.

He stated there's a project at the Farwell Mill that will create 14 affordable housing units at Farwell Apartments and will renovate the structure including exterior façade and roof upgrades and another project matching dollar for dollar up to \$20,000 for business facades.

He gave a letter from the Town Manager to the members that is part of the application process to make sure that this CDBG funding program falls in line with the Comprehensive Plan and meets all of the criteria for the Planning Board.

**VOTE:** (2020-29) Mr. Carr, seconded by Mr. Huston moved to approve and sign the Town Manager's letter.

The chairman extended voting privileges to Pat Maloy since Mr. Kuhl recused himself.

- **9. CODE ENFORCEMENT OFFICER** Mr Douglas spoke about the upcoming Recreational Marijuana legalization on October 9, 2020. The Planning Board put placeholders a while back in their Land Use Chart for Recreational Use for future discussions. He suggested having a joint meeting with the Council to discuss this matter. He stated that MMA, Maine Municipal Association, is putting out a Zoom Seminar on it on October 29, 2020 in which the Town will obtain a copy of it for the Planning Board and Town Council to view.
