Rates: For the 237 public fire hydrants owned and maintained by the Lisbon Water Department (the Department) and connected to the Department's mains on January 1, 2024, there shall be paid to the Department the following public fire protection charge:

Rates: Private fire service rates for automatic sprinklers, standpipes or hose connections to be used only for fire protection inside of buildings.

Service charge per inch of service pipe diameter, per year \$128.91

Each private hydrant with service connection furnished, installed and maintained by user for private fire protection, per year \$773.43
