Rates: For the 237 public fire hydrants owned and maintained by the Lisbon Water Department (the Department) and connected to the Department's mains on October 1, 2020, there shall be paid to the Department the following public fire protection charge:

For each public hydrant owned and maintained by the Department and installed after October 1, 2020, charges will be governed by Chapter 69 of the Maine Public Utilities Commission's Rules and Regulations.

Available: To all customers using the Lisbon Water Department's service for private fire protection. The following rates apply to fire protection only, and include no allowance for water other than fire fighting purposes.

Rates: Private fire service rates for automatic sprinklers, standpipes or hose connections to be used only for fire protection inside of buildings.

Service charge per inch of service pipe diameter, per year \$111.40

Each private hydrant with service connection furnished, installed and maintained by user for private fire protection, per year \$668.40
